

**RULES:**



- You will be assigned Category(s) in a specific Division. Make sure you are clear of which ones you have been assigned. Typically, you WILL NOT be assigned an entire Division.
- You are being asked to return results for 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup>. NO TIES.
- For each of the 3 positions, you will report the ENTRY NAME and IDENTIFIER (Call letters, Publication, Business or College / University) using the RESULTS form provided.
- There is an optional comment area if you would like to describe the winners in general and what led you to make your decision. Your comments are always welcome.



**DIRECTIONS:**

1. Open your browser and go to [www.bestinmedia.com](http://www.bestinmedia.com)
2. Roll your mouse over the "LOG IN / CREATE ACCOUNT" then click on the "Log In / Log Out or Create Account" from the black box that drops down. REMEMBER. ONLY USE THE USERNAME / PASSWORD combinations provided above
3. Enter the username and password into the provided boxes on the log in box.
4. Click on the orange "Log In" button
5. In the top black menu bar, click on "JUDGING".



6. Scroll down the next page and click on IPC link.



7. Scroll down to the bottom of the page. You will see links to the different DIVISIONS. Click on the DIVISION you have been assigned. A JUDGING GRID FOR THE SELECTED DIVISION WILL OPEN

9. Scroll down the “GRID” until you find the CATEGORY you have been assigned. WE HIGHLY RECOMMEND YOU PRINT OUT THE PAGE YOU ARE ON SO YOU CAN TAKE NOTES AS YOU VIEW THE ENTRY MEDIA.

There can be up to 4 media files submitted with each entry. Click on the links in the order they appear in each row of the GRID.

- V1 This is a video that is running from YouTube. It will open in a YouTube viewer
- I1 This is an image. It will open in our image viewer
- A1 This is an audio file. It will open in our audio player
- D1 This is a document / PDF. (single or multiple pages) It will open in our document viewer. Note: It may take a moment for it to appear based on the document size.
- W1 This will open a specific webpage that might represent an article, page layout, web page design...depending on the category entered.
- IS1 This is a link to the eMag site issuu.com. The entrant has chosen to have you view their publication as it was published. It will typically be multipage and it will open in their viewer.

## IPC JUDGING BOOKLET

### STEPS:

1. Go to [www.bestinmedia.com](http://www.bestinmedia.com)
2. Log in using any of the following: judge1 / pa551, judge2 / pa552, judge3 / pa553, judge4 / pa554, judge5 / pa555
3. Click on "JUDGING" in the top black menu bar
4. Click on IPC link on the next page
5. Scroll down and click on the DIVISION you have been assigned
6. Locate the CATEGORY(S) you have been assigned
7. Use the link(s) at the end of each row to view all the media for each entry.
8. Once you finish viewing all the entries in your category, make your decision on 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup>. NO TIES PLEASE
9. Click on the link at the end of each category header labeled "RESULTS."
10. A pre-populated RESULTS form will open.
11. Fill in your information on the first page.
12. Using the dropdown fields, choose the DIVISION and then the CATEGORY you are judging
13. Fill in the ENTRY NAME / TITLE as it appears on the GRID. You can type it or swipe / copy and paste it from the grid
14. Fill in the "Business or Call Letters" as they appear on the GRID
15. Optional. Feel free to add any comments about your selections
16. Submit the form. You will receive a copy of this Judging Results form in your inbox.
